# Report from the Front: The FCCA's efforts before the Zoning Commission to oppose GU's Campus Plan and "Loop Road" along the rim of Glover Archbold Park

The entire process—from the submittal of GU's 10-Year Campus Plan in the last days of 2010 to the many rencent Zoning Commission hearings—has been a complex one, and it's not over yet. The last scheduled hearing will be just days before our June 22 meeting, and the Commission may not release its decision until fall. The hearings are not legal proceedings, but it would be easy to mistake them for such. I cannot emphasize enough the huge number of hours that a handful of FCCA volunteers—primarily our FCCA President Bob Avery, our ANC representative Ann Haas, and our 44th Street neighbors attorney Conrad DeWitte and John Bray — have expended on behalf of FCCA members. These four have spent literally hundreds of hours talking to GU officials, studying GU's plans, meeting with neighboring community groups, researching the facts on key issues, consulting on best strategies, conceiving and preparing arguments and testimony, and finally being present in all senses for seven sessions of hearings, each of which began at 6:30 and seldom wrapped up before 11 p.m. Lest you think they don't have day jobs or family commitments, I assure you that they do. So regardless of the outcome, we owe these four community-minded unpaid volunteers a huge thanks for their untiring efforts. Thanks too to the community members who helped with sign distribution or wrote letters in support of our position; this has been a team effort.

As to the outcome: We don't know yet. It is clear that the Zoning Commission agrees that neighborhoods east and north of the campus need relief from the objectionable conditions created by the ever-growing University, primarily in terms of the affects that student lifestyles have

on their non-student neighbors and property values. As has been fairly widely reported, the Commission seems to be on course to set firm new requirements for GU to house all of its undergraduates on-campus, or face reductions in the numbers of students it will be permitted to enroll. Surrounding neighborhoods are sleeping more easily on that score; our residents also had concerns over more homes becoming de facto rooming houses. GU is not happy.

Some issues of concern to FCCA members seem to have been resolved: the "smoke stack"

disappeared from the final proposed plan, and GU concessions limiting use of Kehoe Field were included. Although we shared many concerns with other citizen groups, our overwhelming issue remains their proposed "loop road", which will degrade both the park and the quality of life in eastern parts of Foxhall Village. This is especially true if the road ends up being the primary entrance for both the campus and GU hospital, including construction and ambulance traffic, which seems very likely. Although no party except GU seemed to be in favor of the edge-of-park option for the road per se, it remains to be seen whether the Commission endorses an edge-of-park road plan, despite the FCCA's arguments that it will have huge, negative impacts on our area and on parklands. Our City Council Member Mary Cheh testified before the Commission

against the loop road, pointing out the absurdity of GU's contention that the only way to enable its GUTS commuter buses to turn around on the campus is to build a road along the scenic easement. #### **New Fees for Trash Supercans**

The Department of Public Works is now charging \$62.50 to replace Supercans, the 32-gallon trash containers used in once-a-week collection neighborhoods. Due to D.C. Budget constraints, the DPW is unable to continue providing a free Supercan to new homeowners and Seniors will also be required to pay the full amount for a Supercan (\$62.50).

Once the container is delivered, residents should put their address on the side and top and record the container's serial number to help deter theft and assist in identifying the container if it does go missing.

The Library, at MacArthur Blvd. and V Street, serves our community and donated books are resold by the Friends group to supplement library programs and supplies.

Donations can be made during regular Palisades Library hours (Mon., Wed., Fri., or Sat. 9:30 am to 5:30 pm, and Tues. or Thurs. from 1 to 9 pm.)

Books can be left in the hallway adjacent to the rear door parking lot entrance; donation receipts from the Friends of Palisades Library (a 501(c) (3) organization) are available at the reference desk on the main floor.

Due to the difficulty in repurposing them, the organization cannot accept computer books, magazines, vinyl LPs and texbooks.

#### **Update on German Embassy** Renovations

ARC Construction Services, Inc. is in charge of phase one of the renovation works (asbestos removal and demolition) which will start this month and last about one year. Scaffolding of the buildings will start after June 14. Phase 1, demolition, is to run until December 2011.

Conditions of the contract for Construction include the following: • ARC will observe noise protection

requirements of the different neighborhoods around the Embassy grounds.

- Access to the site is gained only via the main entrance of the Embassy at 4645 Reservoir Road.
- ARC has to assure handling of jobsite traffic within the working hours, 7 am through 5 pm Monday through Friday only. The neighbors' interests shall be considered. Traffic jams, especially during the heavytraffic morning and evening hours shall be restricted by the assignment of time slots for material deliveries. Jobsite vehicles in the waiting line

outside the construction site shall be turned off—no idling. Loud radio music at open windows is not permitted. Local parking restrictions must be observed. Construction workers will be taken to the site by shuttle buses.

#### Recap on GU's Plan Battle, Cont.

The final scheduled Zoning Commission hearing on June 20 will focus on the Department of Transportation's findings. Afterwards, we hope to have a better sense of the Zoning Commission's leanings on the Loop Road. The June 22 FCCA General Meeting will report on where we are at and potential next steps.

But even that may very well not be the end of this battle. If the Zoning Commission approves the loop road along the Park, despite the objectionable conditions that it would certainly create for Foxhall residents, the FCCA will retrain an attorney and pursue the matter in the courts. That could drag on for quite some time, and we will be outgunned. On the other hand, if the Zoning Commission sides with us and does not approve the loop road along the park, Georgetown University may very well turn to the courts for resolution of the issue, and we will then also need to retain an attorney to monitor the case. Perhaps the best outcome would be if the Zoning Commission postpones a decision on the loop road, neither rejecting nor approving it, until the 10-year-plan for the hospital expansion is filed and hearings begin on that issue. [Ug, indeed.]

#### A List Serve for the FCCA Area CHARLOTTE DONVITO, JAN SMART, AND LISA MACO

On Sunday, June, the FCCA Board voted to approve the creation of an FCCA listserv—basically an electronic bulletin board where subscribers can post and receive a wide variety of information. Listserv postings can be anything from advertising an item for sale, soliciting recommendations for services, such as roofers, babysitters, etc., to recommending a good movie, or putting out an alert for a lost pet. Currently there are several informal email groups among neighbors where this type of information is shared; the listserv will give everyone a far wider reach in the community.

The proposal by a group of Foxhall residents was precipitated by the recent rash of crime in our area. We wanted to find a way to disseminate urgent information, such as crime reports, quickly and effectively to as many in the FCCA area as possible. Many DC neighborhoods have established listservs that have become valuable tools for creating more interconnected communities. The Palisades listsery, for example, has more than 1,600 members and posts approximately 100 messages per week.

All posts on the listserv will be subject to moderating, mainly in order to block spam messages and to ensure that all posts are courteous. The three of us are planning to volunteer initially as moderators, although other volunteers are welcome! Over the summer, our goal is to prepare clear guidelines for the moderators, which will be subject to Board approval. These guidelines as well as detailed, step-by-step instructions for joining and using the listsery will be published in the FCCA Newsletter in the Fall.

#### **Stepped Up Enforcement and Significant Fines Reported for Failures to Get Required Building Permits**

We've been hearing of significant fines being imposed lately on people doing construction without building permits when a permit is required. There seems to be stepped up enforcement, so get those permits!

DC building permits are required for many common renovation projects. Below is a partial list of exterior work that requires a permit (whether you live in the Foxhall Village Historic District or not, and whether you are renovating the front of your home or the back):

- Additions
- Decks, new or replacement
- Dormers, new or replacement
- Exterior lighting, new
- Fences, new or replacement
- HVAC equipment, new or replacement
- Paving (including steps), new or replacement
- Retaining walls, new or replacement
- Roof, replacement

#### Additional permits required for the **Historic District only:**

- Front doors, new or replacement
- Windows, new or replacement
- Window openings, new or expanded (only allowable in the rear of homes in historic district)
