About the City Council: The Council of the District of Columbia is the legislative branch of the District government. All legislative powers are vested in the Council. In addition, the Council approves the District's annual budget and financial plan, and sets the revenue required to fund the budget. It oversees the programs and operations of government agencies, and acts on or initiates reorganization plans for the Executive Branch. The Council determines land use, through the adoption of the comprehensive plan, and undertakes redistricting based on the decennial census. In addition, the Council appoints members to certain boards and commissions, and must confirm major appointments made by the Mayor.

The Council develops legislative initiatives and budget priorities to promote the public welfare. It oversees the performance of government agencies and the implementation of management reforms to improve service delivery. Council committees issue analytical reports on the effectiveness of government operations and make recommendations for reform. In addition, the Council monitors agency spending to ensure compliance with the approved budget and financial plan.

As the local elected representative body, the Council seeks citizen participation throughout the legislative process. It holds public hearings to provide an opportunity for public comment on proposed legislation, policy initiatives and government operations. Also, the Council helps citizen's access government information and services.

# Membership is Important

People are joining the Foxhall Community Citizens Association at the fastest clip in four years. The rolls hit 110 in January, with eleven new members — very encouraging for your cadre of FCCA volunteers!

The FCCA welcomes the trend and encourages everyone's participation because the area faces great challenges in 2010. We must find ways to stem the rush hour surge of cars through our capillaries, monitor Georgetown University's

expansion and generally stay on top of the burgeoning development all around us.

These complex issues require the engagement of the collective intelligence and energy that our community is so fortunate to possess.

The FCCA area encompasses about 900 households, and the Association closed 2009 with about a fifth as members, which is, in fact, a very high rate compared to other community associations.

# **January 20 FCCA Meeting** Recap: GU's 10-Year Plan

Police report: Officer Anthony McElwee noted in our regular police report that new signage has been installed at the intersection of 44th and Foxhall Road and officers will ticket for blocking the box. No Right Turn signs have been requested for P and Volta Streets at Foxhall for northbound traffic during AM rush hour to reduce cut-through traffic.

There's been a sharp increase in theft from autos in our area recently, especially GPS devices and cell phones. Please report any suspicious activity by calling 911!

Officer McElwee also offered to do home checks while you are on vacation if you email him personally at anthony.mcelwee@dc.gov.

Miscellaneous Items: Public thanks were given to Rodney and Connie, Hardy Recreation Center Staff.

And Kent Slowinski of the Foundry Branch Watershed group made a brief presentation on a new initiative for watershed and wetlands clean-up and invasive plant removal in Glover-Archbold Park. The group is working to secure grants for work.

Georgetown University's Ten-Year Plan: Linda Greenan, Associate Vice President for External Affairs at Georgetown University, made a presentation on GU's Ten-Year Plan as required by DC zoning. Their current plan expires this year and when they officially file the new plan, a series of hearings for community involvement will ensue. To download the plan and receive e-mail updates, go to http://community.georgetown. edu/campusplan.html. To contact Ms. Greenan directly with concerns, call 202-687-5677.

Issues raised relating to the plan at the meeting and Ms. Greenen's responses:

1. Concerns regarding a proposed height increase of on-campus smoke stack from 10 to 83 feet, for emissions and vistas.

- 2. Concerns about housing and traffic related to plans to increase the number of graduate students by 3,000. LG responded that GU will add 120 beds, and is doing research to better understand the issue. She felt that about half of the proposed growth would be in programs intended for working professionals, who probably already reside in the area and would be taking weekend and evening courses.
- 3. Concerns related to a proposed new or expanded road to run along GU's rim of Glover Archbold park involved lengthy discussion. The existing road has recently collapsed with trash and other refuse ending up in the eroding area below. Concerns about noise, air quality, impact on wildlife, integrity of the National Park, and ability of the slope to support additional weight were raised. LG stated that the intent of the road is to provide turn around and a loop road through campus for Georgetown University Transportation System buses, in part to route most traffic to the campus's Canal Road entrance and away from Reservoir and Georgetown.
- 4. A proposed roof over the Yates Field House field raised concerns about the roof height, view obstruction, noise from games or other possible GU events, light pollution, and roof run-off. LG responded that details are not yet available, but there is no intention to use the field any differently than it is
- 5. Concerns about green building best practices: A GU faculty group is working to address environmental issues of the plan.

Recommendations for FCCA Community Response on the Plan: Download and review GU's draft ten-year plan at the address provided above. Communicate concerns to the DC Department of Transportation and the Area Neighborhood Commission, which the Burleith and Georgetown

neighborhoods are already doing. Petition DDOT, ANC and GU on areas of concern. Express concerns to Georgetown University directly. Express concerns to the National Park Service about proposed construction and use of Park Road and to Georgetown University directly.

A site tour of proposed Park Road with GU will be arranged by ANC Commissioner Ann Haas, as will a tour with NPS. The FCCA will be formulating communications based on meeting comments on behalf of the community.

# **GU Community Hotline**

On a somewhat separate issue, Linda Greenan reminded us about GU's Community Hotline, maintained by Georgetown University to deal with issues related to students living off-campus. The hotline is operational 24/7 but response vehicles are only on duty during the busy weekend evening hours. Call the Hotline at 687-4813 for ANY issues where GU students are negatively impacting the quality of life in the neighborhood, including but not limited to parties. We were assured that sanctions against repeat offenders do happen and can have a positive impact on our community if we avail ourselves of this advocate. Note that it is not necessary to have all information such as student names. We were assured that GU will connect the dots as needed. For more complex or nuanced issues, you can also call Ms. Greenan and discuss the issue; her number is 687-5677 during business hours.

## Hardy Rec Center Blows its Top JOHN BRAY

A storm that blew the roof off the Hardy Recreation Center turned out to be a wind of change that brought much-needed repairs across the board at the playground. Department of Parks and Recreation officials were at Hardy on the morning of Jan. 25 to survey the early morning damage to the building, which looked like a torn open can of sardines. There were no injuries.

Groups that ordinarily use the building were temporarily relocated to the Palisades. Officials initially estimated that it could take a week to put the house back in order. But by the next day workers were on top of the building replacing the copper top with a new shingle roof. New gutters and downspouts also were installed.

The work by Ridge Construction cost \$24,000, money to come from DPR's Capital Projects fund, according to spokesman John Stokes.

The building reopened Feb. 1. The city took advantage of the closure to tackle a host of other smaller repairs around the facility, including repairing light fixtures, stripping and waxing interior floors, painting walls, fixing bathroom doors and tiles and replacing fence latches. More is on the to-do list. Andrew del Junco, a Ward 3 outreach and services specialist, said the city also intends to add a crosswalk for Q Street in front of the center, fix a cracked pole on the basketball court and improve signage, among other tasks.

A BIG thank you to all of the community members who have shown their consideration for others by shovelling their sidewalks (and shovelling and shovelling some more!)! It was especially important as we all turned to our feet to get around the area.

## **Illegally Parked Cars**

Report cars obstructing sidewalks or displaying suspicious guest parking permits by calling 311.

Note: D.C. law requires people who live in the city for more than 30 days to register their cars with the D.C. Department of Motor Vehicles or face a \$100 ticket every day. This applies to cars parked on private property as well as on streets.

#### **Unpermitted Construction**

For unpermitted construction or work that appears to violate code, call DCRA at 202-442-4400 and they will send an inspector very quickly. Calls can be anonymous. # Hayes-Crow **Quiz Answers**

- 1: Whitehaven was the 1689 759-acre land grant that included all of our area between Glover Archbold Park and Foxhall Road up to around Garfield Street. The original 1754 Whitehaven house still stands (much altered) at 4928 Reservoir Road, overlooking the Potomac as you descend to Fletcher's Boathouse. Thomas Jefferson frequently visited and bought plants for Monticello from one Whitehaven resident, horticulturalist Thomas Maine'.
- 2: Spring Hill was located just east of Foxhall Road near where P Street now is. The farm had 60 acres, was sold in 1908 and much of it is now part of Foxhall Village. The house was razed in 1921. One house on P appears to have stones in the cellar that seem to be from an original Spring Hill foundation.
- 3: Ridge Road; from 1863 to 1942, it was Conduit Road. It was renamed by Congress and the White House while the famous general was fighting in the Pacific.
- 4: It's Foundry Branch, named for Henry Foxall's foundry that was located near where the creek crosses Canal Road.
- 5: Around 1900—I've seen dates of both 1899 and 1901. The sluice gates under the "castle" lead water to the MacMillan Reservoir up by Howard University.
