

## The September 21 General Meeting: Development Developments

One neighbor's idea of a good development in the neighborhood is another's idea of over-scale, overly-dense destruction of the fabric of the community. But one thing is clear: there are a lot of big projects underway in our neighborhood and others on the horizon. Keeping a careful watch on them—and our community's feelings about them—is essential. With that in mind, the September meeting will provide updates on several issues and projects:

**Police Report:** The Police believe they have some breaks in the spate of serious incidents that have plagued our usually safe and quiet neighborhood in the past year.  
**Georgetown University's 10-Year Campus Plan:** It shouldn't be news to anyone that all the neighborhoods surrounding Georgetown—the FCCA, Burlieth, and Georgetown—are all strongly opposed to various aspects of Georgetown's plan. FCCA President Bob Avery will give us an update on how the fight stands.

**St. Patrick's Sports Facilities** construction on Foxhall Rd: You've probably seen the mountains of earth being moved about. A representative from St. Patrick's will update us on what is being built, and the scheduling the potentially disruptive reconfiguration of Foxhall Road to allow for a new turning lane and other modifications.

**Foxhall Ridge:** The Riverside Hospital has been closed for years now. Canal Parc, an earlier project of rather dense up-market townhouses, didn't go ahead despite approval by the Zoning Commission. Foxhall Ridge is now under construction, following the Canal Parc plan. We hope to have a representative give us a brief update on the project.

**German Embassy Reconstruction:** The German Embassy on Reservoir Road is in the beginning phase of a major overhaul. Stefan Laetsch, Head of Administration at the German Embassy, will also join us at the September 21 General Meeting to answer any questions community members may have.

## Status Update on FCCA Efforts to Oppose Parts of GU's Plan

The most recent meeting of the Zoning Commission was on June 20. At this relatively short meeting, the Zoning Commission agreed to postpone the community associations' cross-examination of Georgetown University's representatives. Part of the reason for this delay was to give GU time to collect traffic data in September when classes are in session in order to prepare a supplemental traffic study. GU's representative also expressed a desire to work with the community associations and other parties in an effort to address opposition to GU's 2010-2020 campus plan. Thus far, the FCCA has not been contacted by GU.

The next meeting of the Zoning Commission is presently scheduled for November 17 at 6 PM, the day after the FCCA November general membership meeting. At the Zoning Commission, we expect the Community Association of Georgetown, Burleith Citizen's Association, and FCCA will cross examine Georgetown University's representatives on their campus plan.

## Notes from the June 22 FCCA General Meeting

Bob Avery, FCCA President, reported on the status of the FCCA opposition to GU's 10-Year Plan. Bob began by acknowledging Conrad DeWitte who served as a pro bono attorney, assisting in the preparation of cross examination at City Zoning Hearings. At the last hearings, Bob stated that GU had not demonstrated any meaningful defense on the matters before them relative to the over-saturation with GU students in the neighborhoods of Burleith and West Georgetown. Twenty percent of GU's undergraduate students live in these neighborhoods, and many homeowners feel overwhelmed.

They expressed sentiment that GU's administration has done little

to monitor its students and has mismanaged its relationship with the community.

The two main issues that crystallize FCCA's opposition are:

1. GU is threatening to increase the graduate student population by twenty percent. FCCA has joined groups in Burleith and West Georgetown to oppose this effort.
2. The Loop Road. GU wants its main campus entry to be on Canal Road and a "Loop Road" near the edge of the Glover Archbold Park with buses running every fifteen minutes from 4:15 am to midnight. FCCA has proposed an alternate route directing all traffic into the center of campus.

GU has the burden of proof at this time and has asked for a continuance until after Labor Day. By a vote, the members present empowered Bob to negotiate on this issue with GU but not to sign off on anything.

The police reported a thirty-five percent reduction in crime during the last year in our area. Nonetheless, there has been a recent surge in crime with three stolen autos and three burglaries, all through unlocked doors and windows.

An FCCA List Serve was approved. This will serve as a way to post community messages and a proactive way to get emails sent. Paul DonVito will monitor this and put it on the FCCA website.

Mary Rollefson presented the proposal to make the alley between Q Place and Q Street across from the Hardy Recreation Center a "Green Alley" to mitigate the effect of storm water rushing through and causing erosion, and to make the alley safe for pedestrians. A grant has been awarded and work is expected to begin soon.

## Nominations for the FCCA Board

The FCCA Board of Directors will be elected at our November 16th General meeting.

We would like to have each of the FCCA neighborhoods represented on the Board. However, to accomplish this we particularly need members who live along MacArthur and/or south of the Boulevard.

Directors serve a one-year term, must be a member of the FCCA and live within the FCCA geographic area. The Board meets once a month, usually the last Sunday. Each Director assumes responsibility for an area of interest, such as police liaison, school liaison, traffic concerns, development, etc. The Board as a whole sets the agenda for the membership meetings and acts in lieu of the membership when issues arise that require immediate action.

Being on the Board is a great way to keep abreast of what's happening in the neighborhood, to meet new people, and to make a difference in your community. Thank you for considering it!

## Welcome New Neighbors, Permanent and Temporary

This is a very welcoming neighborhood with a great mix of residents from the very young to the very old. It is, however, a strongly residential neighborhood, and “we have our standards.” Please note:

**Loud Parties:** We all like parties too, but please note that it is “unlawful for a person to make an unreasonably loud noise between 10 p.m. and 7 a.m. that is likely to annoy or disturb one or more other persons in their residences.” The penalty for violation of this law? 90 days in jail and/or a \$500 fine! Harsh! Neighbors are considerate if they give you a warning that you are disturbing them, but hosts need to make sure their parties don’t disturb neighbors. Talk first, but report problems to 911.

**Enjoy Hardy Field:** The field is a wonderful resource but use by over 10 people for an hour or more requires a permit from Parks and Recreation. You can do it online. The field gets a lot of use so please be considerate with leashed pets and cleanup. No alcohol.

**We Need Our Sidewalks:** There are a lot of walkers in this neighborhood. Please don’t park in driveways so you block the sidewalk, and make sure to get a shovel before the snow flies. It is all—students included!—residents’ responsibility to shovel their sidewalks in front of residences soon after snowfalls.

**Parking Permits:** Note that parking “reciprocity” permits (for residents who wish to retain out-of-state registration for any reason) are not granted in this area. To park on the street, you must register your car in the District of Columbia.

**Trash:** Please call 311 for free bulk trash pickup of unwanted over-sized items and put regular trash out only on designated days in supercans to help us control rats and vermin. The city is fantastic about making these pickups.

## Before Trying to Enter Your House, a Thief Looks for...

Newspapers on your walkway; packages, mail and flyers by your front door; a purse, wallet, cell phone, keys in view through a window; a front door that’s wide open, especially if there’s no screen/storm door; unlocked windows; no lights on; uncut grass and hedges; and weeds and ivy growing over walkways and steps.

A thief will also try to open doors and windows and just walk/climb in. To prevent this:

- Install window blocks to prevent windows being fully opened
- Use a block to prevent sliding doors from being opened
- Use a deadbolt lock on your front and back doors.
- Turn on your alarm system, if you have one.

Whether you’re home or not, keep lights on timers, keep the porch light on, keep a radio or TV on. Let would-be robbers think you might be home and thus a robbery would be too risky.

Keep the front and back of your property cared for and eliminate hiding places. You might also consider installing a motion detector light and/or an alarm system.

When you’re away, even if it’s just for one night, ask a neighbor to pick up your papers and mail. If you’ll be out of town for a length of time, you can stop paper delivery and have the Post Office hold your mail. You can also request that the police department check your property periodically. Nothing will make you 100% safe, but there are many things you can do to deter a thief.

## JOIN THE NEW FCCALISTSERVE!

The FCCA listserve is up and running thanks to Charlotte DonVito, Lisa Maco, and Jan Smart, who are administering and managing the FCCA electronic bulletin board where subscribers can post and receive a wide variety of information. The FCCA listserve exists to facilitate communication about events and items of interest to the residents and businesses of the FCCA community. Postings that directly concern life within the FCCA boundaries are preferred, but certain broader, citywide issues are also appropriate. Spam of any kind will not be tolerated, and such postings will get the poster banned from the listserve. Postings by residents such as “house for rent” or “car for sale” are permitted, but commercial postings (including political ads) are not. Although a lively exchange of ideas about issues affecting our community is encouraged, all communication should be polite and respectful in tone and content. Postings are not anonymous and must include your street and a user name, but not a complete address.

**Complete step-by-step instructions for joining the FCCA Listserve are available on our [www.foxhall.org](http://www.foxhall.org) home page as a tutorial PDF document.**

The short version is:

**Create a Yahoo account** with a user ID and password if you don't already have one at [www.yahoo.com](http://www.yahoo.com). Your ID allows you to log in to Yahoo.com and search for the FCCA Listserve. The ID you create is the name that shows up on any messages you post.

**Join the FCCA listserve.** Scroll down to the heading *More Yahoo! Sites*. Select *Groups* to see the Yahoo! Groups page. Type *fccalistserve* in the search field and select *Join This Group* when the name appears. A request is then sent to our Moderators, who will approve your membership. You will receive

an email message when a Moderator approves your membership so you can read and post messages.

**Getting Messages:** Yahoo gives you options on how you get fccalistserve message: 1: Receive an email whenever there's a new post. This keeps you most up to date for breaking issues, but also can fill up your email “inbox”. 2: Get a daily summary email with all the posts made in the last 24 hours. You can scroll down to read any that interest you. 3: Get no emails at all—you go to [yahoogroups](http://yahoogroups.com) to read fccalistserve messages. Which is right for you? It depends. If you want to know immediately that a threatening situation has been spotted in the neighborhood or that someone is giving away free money, opt for the instant emails. If you *only* want to be able to research the database, opt for no emails. Most people seem to prefer daily summary emails.

**Read a Message:** When go to the fccalistserve group, you will see the Home screen, with all messages for the last seven days. Click on the blue subject line and the entire message will be displayed with the date it was posted, and author.

**Reply to a Message:** Hit the Reply button and an input screen appears. Type your text into the text box above the original message. Hit Send and a confirmation screen is displayed.

**Post a Message:** There are two ways to post a message to the FCCA listserve: 1. By sending an email to [fccalistserve@yahoogroups.com](mailto:fccalistserve@yahoogroups.com). 2: From the FCCA listserve page. To post a message from within the FCCA listserve page, select *Post* under the Messages heading in the left-hand sidebar. Enter a short description in the subject box and the rest of your message in the main box. Be sure to include your first name and street name in the body of the message. Press *Send*. Using either method, a moderator must approve the message before it shows up on the list serve.

**Deleting a Message:** To delete a message you have posted, select the message from the home screen and then press the *Delete* button at the bottom of the screen.

## FCCA LISTSERVE FAQS:

**Do you have to be an FCCA member to join the listserve?** No!

**Do you need to live in the FCCA area to join the listserve?** Generally yes, but is subject to the discretion of the moderators. Ask.

**Do you have options on what messages you receive and how often?** Yes. There are controls on the yahoo site, and you can always change your preferences.

**Is it worthwhile?** It will take awhile to grow and become a truly rich community resource but the Board strongly believes that the answer is an unqualified “Yes!” Based on the popularity and usefulness of the Palisades listserve, we believe that an FCCA listserve will fill an important niche for very local and up-to-date information on a range of issues and emergencies.

## What is the relationship of the FCCA listserve to the FCCA?

The listserve is under the auspices of the FCCA and its elected volunteer Board, but the Board is not running or moderating it. FCCA Board Member Paul DonVito serves as a liaison between the Board and the listserve moderator volunteers, who are otherwise doing this independently on their own initiative.

## Ever wonder about the tunnel under the Canal at the river end of Glover Archbold Park?

Every time I've passed through the tunnel, I've wondered at its age and purpose. It's a rather elaborate structure just to get pedestrians across the canal—the simple solution obviously would be a simple pedestrian bridge. And it seems older than time, but why was it built? The answer lies in the history of the Foxall Foundry, which used to sit along the Potomac near the tunnel.

The Foxall Foundry (called at various times the Columbia Foundry), was active through the war-torn period of 1800 to 1854 and was one of the most important industries in Washington in its time. In its early days, it was the young federal government's only supplier of quality guns. Few records remain, however, that provide details about the facility, which was developed with state-of-the-art technology by Henry Foxall when the U.S. government moved to Washington from Philadelphia. Foxall, a prominent English iron-foundry owner, owned earlier foundries in Philadelphia that primarily cast agricultural implements. He moved his business from Philadelphia to Washington at the behest of Thomas Jefferson, specifically to produce cannon, shot, and carriages for the federal government as a patriotic venture. Though details about the site are scarce, by 1803 there was a blast furnace, a boring mill, and three other buildings. The boring mill was powered by a water wheel, using Foundry Branch. The foundry continued to be enlarged after 1803. An 1836 account described it thusly:

*"It is situated on the northern margin of the River Potomac about a mile above the western limit of the City of Washington. There is good navigation*

*for vessels of two to three hundred tons to the spot. On it are erected a number of substantial and capacious buildings of stone and brick, conveniently arranged and furnished with the requisite water wheels, machinery, implement, and tools for carrying on actively the different branches of the work in which the establishment is engaged. It binds on the river and has deep water touching it for upwards of seven hundred feet. The Canal pervades it for a distance of about eight hundred feet. And extensive wharf on the ridges side gives the facility of loading and taking off from large vessels everything from or to the tidewaters of the Chesapeake or seawards. The banks of the Canal in the interior of the site afford the same advantages on both sides of it for what my come from or be sent to the upper country.*

*"...A capacious and lofty casing house of stone, containing four large air furnaces with double stacks; an extensive moulding floor; deep pit for casting canon; drying room, with iron doors, for baking gunmoulds; three powerful cranes, fitted with the requisite iron pinions, sleeves, and chains; a room for preparing moulding material; iron railway and carriage for moving fans in and out of the drying room; railway and carriage for transporting same from the casting house to the boring mill. ..."*

According to this report, the facility at that time consisted of a great many impressive buildings and industrial facilities that could produce up to nine cannons at one time.

Foxall's cannons were used in the War of 1812 on land and on ships. They were used in many frontier expeditions, and the foundry was a key target of the British when they attacked Washington. Only a severe storm prevented the British making it past Georgetown to destroy the foundry.

Henry Foxall sold the foundry to John Mason in December 1815. Mason continued to have a near monopoly on government ordnance

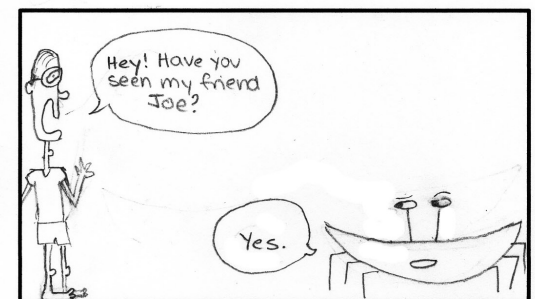
of the types it produced until 1816, when competing foundries began to come on line in other areas and the U.S. government moved towards competitive defense contract bidding. Though very successful throughout the 1820s, by 1835 under the aging Mason's leadership the foundry failed to keep pace with technological developments or maintaining the quality standards for which it had become widely known. Mason sought to sell the foundry to the government as a national foundry. In one document related to that attempt, Mason discussed his relatively few major improvements to the site, including an access road under the new Chesapeake and Ohio Canal. The Canal was begun in 1824. The first 26-mile-long section, from Georgetown to Seneca, had opened that same year in 1831. So that is the history of the tunnel: it was built around 1831 as part of the Foxall Foundry. The foundry continued to operate until 1854, but on a much reduced scale after Mason's death in 1849 at the age of 83.

## German Embassy Construction

The work on the first phase (demolition) of the German Embassy renovation is now underway and proceeding according to schedule. The demolition is expected to be completed in December and will be followed by a short lull in activity before actual renovation work begins. Embassy officials have assured us that all areas where there are hazardous materials (either from asbestos or exposed lead paint) are being sealed off and handled according to U.S. building and construction regulations. To date, there has been minimal disruption to morning or evening rush hour traffic and Embassy officials are taking steps to ensure minimal disruption throughout the entire duration of the project. The Embassy was quick to respond to some complaints from neighbors about day workers arriving early and waiting outside the gates prior to the beginning of the work day. The contractor and subcontractor have been notified and have already taken remedial action.
