Wednesday, Jan. 20 FCCA General Meeting to Focus on Georgetown University Plans that May Negatively Impact our Community

The meeting will feature a presentation by Georgetown University Officials outlining their proposed 10-Year Campus Plan.

Georgetown files a Campus Plan once every 10 years, per city law requirements, that outlines future infrastructure projects and development on the Main Campus and Medical Center. The D.C. Zoning Commission must approve the plan. The current campus plan expires on Dec. 31, 2010, and the University hopes to file the next proposed campus plan this month.

Georgetown is proposing an increase of 3,000 graduate students. This could substantially increase demand for student housing in our neighborhood and represents an increase from 3,500 graduate students in 2000 to 5,545 this year to a planned 8,750 by 2020. Other changes include their transportation system, with all entrance/exits off moving to Canal Road and entailing the construction of a new internal road on the edge of Glover Park, and talk of a major renovation for the hospital and a doubling of the height of the smokestack used for their power station.

These proposals could have a significant impact on our area. It is very important that we be engaged as a community and offer informed input into the process or our voice will not be heard. Please join us on the 20th for this important meeting.

Metrobus Service Changes on D routes

A number of changes are coming to the D bus routes beginning Sunday, December 27.

Three bus lines are restructured and operate with new line names, the Glover Park – Federal Triangle Line (D1), Ivy City - Dupont Circle Line (D3) and Ivy City - Franklin Square Line (D4). D5, D6, and D8 schedules will change to provide greater frequency of bus service in combination with the new routes.

Earlier this year, Metro hosted four public meetings on the D bus lines as part of a Service Evaluation Study to review the productivity, travel time and reliability and to make recommendations for more efficient bus operations. Customer feedback, along with information from bus operators and planners was used to examine ridership, frequency, travel time, reliability and other quality-ofservice indicators for the D bus lines.

D5 MacArthur Boulevard -Georgetown Line: Two additional westbound buses will be scheduled to depart at 3:20 and 6:55 p.m. from Farragut Square.

D6 Sibley Hospital - Stadium **Armory Line:** The weekday schedule will change. Buses servicing the route between Sibley Hospital and Stadium-Armory Metrorail station will be scheduled every 22 to 25 minutes with shorter route buses servicing during the afternoon peak period. Eastbound short trip buses to Stadium Armory will leave Farragut Square (on 17th Street) at 3:14, 3:39, 4:02, 4:25, 4:45, 5:09, 5:32, 5:54, and 6:13 p.m. Westbound short trips to Sibley Hospital will leave Farragut Square at 4:47, 5:11, 5:37, 5:59, 6:23, and 6:47 p.m.

In Our Gardens

English ivy (Hedera helix) is ubiquitous in the gardens of Foxhall



Village and surrounding neighborhoods. As gardeners know, English ivy is a hardy evergreen and

a reliable ground cover. Native to England, it also has that Ivy League appeal. However, gardeners know too that English ivy will quickly grow into and atop bushes, up tree trunks, and crowd out other plants.

But, that is not all. English ivy will invariably "escape" from gardens and invade parklands, forests and other natural areas dominating the native plant habitat. Birds assist in this relocation by ingesting the ivy's berries and distributing its seeds. Some gardeners help its spread by disposing of ivy cuttings in natural areas.

Once in a parkland, such as Glover Park, English ivy climbs native trees weakening the host plants' ability to thrive. In the winter snow and ice collect on the dense ivy foliage and this added weight can topple a tree. Our native habitat has few defenses against English ivy.

Is it any surprise that English ivy is considered an invasive plant in the DC area? Gardeners are urged not to plant it. But if already planted, gardeners are urged to contain it and discard any cuttings in a responsible manner. Or ideally gardeners can remove it by pulling up its roots and by cutting the vines growing on trees at the base and pulling the vine away from the trunk.

Unfortunately, English ivy is not an anomaly. Periwinkle (Vinca minor) is another invasive plant. So, what do gardeners plant? The US Botanic Garden offers several suggestions for

attractive ground covers native to this area, one of which is the Heath aster (Aster ericoides).

Use of the field by any group requires a permit. "Rogue teams" playing without DC Parks and Rec permits, and use of the field following heavy rainfall by any group is not allowed. Any misuse of the field should be reported immediately to the Urban Rangers at 311.

Report cars obstructing sidewalks or displaying suspicious guest parking permits by calling 311.

Note: D.C. law requires people who live in the city for more than 30 days to register their cars with the D.C. Department of Motor Vehicles or face a \$100 ticket every day. This applies to cars parked on private property as well as on streets.

To Report Unpermitted Construction

If you're concerned about unpermitted construction that you see, or work that appears to violate code, call DCRA at 202-442-4400 and they will send an inspector very quickly. Calls can be anonymous. Real Estate Corner

2009 was an interesting year in real estate just as it was in the financial markets. The big difference between the two is that our single family homes here in Foxhall/Berkeley/ Palisades only dropped 3 to 5 percent. We can only wish our IRAs had done as well.

What I had noticed at the beginning of the Spring real estate market was that owners were making the decision not to sell their homes in fear of losing equity, or ending upside down in a buyer's market. This lead to a tightening inventory which dropped noticeably more through the summer months and did not take the traditional rebound for the Fall market. The inventory trend continued downward from October through December with the number of houses available well below 2008 inventory. Overall inventory for single family homes in the District for 2009 was down 27.6 percent

Throughout this period buyers continued to actively seek and purchase homes. This created a pent up demand for homes which also helped keep prices up. As I had mentioned in previous articles, there were even cases of multiple offers, although not all led to sales prices in excess of asking price. Comparing sales data from 2009 to 2008 it is interesting to see that the usual slow months of summer provided strong sales. The months of October, November, and December provided very strong sales. This was completely contrary to past years when the market was essentially over when people sat down for Thanksgiving dinner. Overall sales for single family homes in the District for 2009 were up 28.3 percent.

A last interesting fact was that the hottest sector of the market in our corner of DC was for homes priced

between \$600,000 and \$799,000. Sales in this price bracket were up 20.8 percent. I experienced this first hand with seven sales in the neighborhood.

Within our neighborhood there were 33 sales in 2009, ranging from \$475,000 to \$1,900,000. There are currently two houses under contract, and nine active listings ranging from \$769,000 to \$3,849,000. The home for \$3,849,000 is a new construction home at 1821 Hoban Road and is part of the new development on Foxhall Road. Contact me if you have any questions at scott.polk@LongandFoster.com

A Reminder to Homeowners about Getting Building Permits

With the spring construction season just around the corner, remember that many renovation projects require building permits. Almost all exterior work — decks, roofs, retaining walls, fences, dormers and HVAC equipment, additions or demolition — needs to be signed off by the city and permits must be displayed in a front window. Even some interior work, like certain electrical or plumbing projects, requires permits. And if you live in the historic district you also need a permit to replace your windows, front door or front paving (any change to street-facing elevations are subject to review.)
