# Foxhall/Palisades Real Estate Corner

Inventory continues to be a major driving force in our real estate market. Throughout this year inventory has been consistently low. October 2012 inventory was 34.9% lower than this time last year. This doesn't necessarily mean homes are selling for inflated prices, although well priced homes in move-in condition do sell in 2 to 3 weeks. For buyers, the largest issue has been property condition. Although there is a shortage of homes, buyers have had a fairly high expectation, wanting houses with improvements and/or to be in move-in condition.

Currently, there is more of a trend for buyers to be a bit less selective. Similarly, sellers have been more realistic about pricing. Interest rates have been helpful because of the historically low rates which make mortgages more affordable for buyers. Overall, this has led to increased sales volume.

Looking at the statistic, homes in our area have sold between \$615,000 and \$2,250,000 for an average/median price of \$814,000/\$1,012,822. On average, homes have sold in 29 days at 97.34% of asking price.

In marketing your home you are faced with two major decisions. First, what sensible improvement/repairs should be made prior to selling your home; and second, the price at which to sell your house. The first decision will affect the second and you need to make dollars and cents decisions that will benefit you. #### **Relief from the Party Noise**

The disorderly conduct law passed by the City Council became effective citywide in February 2011. This includes the new "Noise at Night" violation that has been mentioned in the media. While the MPD will continue to work with individuals and communities to appropriately balance the rights of each, the new law makes it clear that a person who makes an unreasonably loud noise between10:00 p.m. and 7:00 a.m. that is likely to annoy or disturb one or more other persons in their residences is violating the law and may be subject to arrest. The maximum penalty for a conviction for disorderly conduct is a \$250 fine and up to 90 days of incarceration. D.C. Criminal Code § 22-1321.

### Thefts from Autos

One of the most common types of theft is theft of valuables from your automobile. Theft from auto is strictly a crime of opportunity that can be prevented if you take away the opportunity. Thieves generally don't waste time breaking into cars that don't have valuables in plain sight. Please take the precautions listed below to help ensure your auto is not targeted by thieves:

Keep Your Valuables Out of Sight The best way to prevent theft from your auto is to always keep valuables out of sight. Never leave cell phones, briefcases, suitcases, or electronic devices (cell phones, iPods, laptop computers, etc.) in plain view. Take these items with you, or secure them—all the time, every time.

Secure Your GPS Device While many GPS devices are mounted in the dashboard of the vehicle, the police department encourages anyone who uses a portable GPS device to take it with you when you park the car.

#### Use Your Trunk

If your car has a trunk, use it or utilize a locked glove compartment. Hiding items under seats is better than leaving them in plain view, but securing them inside the glove compartment or trunk is a far better deterrent.

## Don't Tempt Thieves with New Purchases

During the holiday season especially, or any time you're shopping, place packages in the trunk.

*Remove Your Radio Faceplate* If you can unfasten your sound system and take it with you, or lock it in your trunk, do so. And don't forget to do the same with your CDs and tapes.
