

### **Airplane Noise**

I represent the Foxhall Community Citizens Association as the airplane noise representative. I have lived here since 2011, but in 2014 noticed a marked worsening in noise from Reagan early and late at night, large landing planes flying very low directly over Foxhall Road, and extremely loud takeoffs over Hardy Park. I reached out to representatives to find out how to remedy this health and safety issue, and greatly appreciate Congresswoman Norton and her staff for their attention to this issue and bringing Metropolitan Washington Airports Authority (MWAA) and Federal Aviation Administration (FAA) together.

It is unfortunate any of us have to waste our time dealing with what should be an obvious fact - large jetliners flying into the heart of Washington, DC at all hours of the day can't be a good idea, not only for

noise in our little neighborhood, but for peace on the national mall, and for national security. This situation was supposed to be prevented by Congressional limits and MWAA, but the relaxation of perimeter rules, lengthening of runways, expansion of hold aprons, planned terminal expansion, and now MWAA's deals to share over 300 million dollars of profits from Reagan to struggling Dulles, it seems it will only get worse at the expense of polluting our nation's capital. Noise is not a new problem - in fact in 1787 the cobblestone streets of Philadelphia were closed so our founding fathers could concentrate on the Constitution... now ironically the monuments to many of those great men stand on ground deemed by the EPA noise control act of 1972 unsuitable for outdoor use and by a recent 2013 federally funded study are exposed to noise that likely causes heart disease and stroke. Now conversation must stop in the Rose Garden for a passing Southwest flight attendant in khaki shorts and silence at the Vietnam Veterans memorial can't be observed when rock concert level noise passes every 30 seconds.

While we can't hope to fix the growth at DCA tonight, we have four simple goals we hope to work with the FAA and MWAA to achieve to improve safety and noise.

First, All landing flights must be over the river, not our homes. While a 2013 FAA report showed these overland routes had been nearly eliminated, on a recent Sunday night, in 6 hours, over 85 planes flew as low as 600 feet over our homes. To keep all planes over the river, all crews must be trained and planes equipped for NextGen navigation via the Rnav RNP approach in IMC when the river visual approach is not possible. The minimum altitude over residential areas must be raised and

basic noise abatement enforced such as not extending landing gear beyond a three mile radius.

Second, The new NextGen LAZIR departure routes all planes over the Kennedy Center, Foxhall Village, Hardy Park, and the Palisades neighborhood including 5 schools, while sparing the commercial Rosslyn district. This route must be eliminated, and a new path redesigned to route planes over the less populous bank with the wide and noisy GW parkway. Also planes heading northeast must use the Anacostia corridor and those heading south and west must use the I-66 corridor, as the burden of takeoffs has exceeded reasonable capacity for one route. All takeoffs must use basic noise abatement measures including fast climb to over 5000 feet by four miles and low engine thrust over residential areas.

Third, the 10pm to 7am curfew must be reestablished as is possible in other crowded areas like Orange County and San Diego. Currently 4 flights depart before 6am directly over our community which is unacceptable and disturbs health and sleep of tens of thousands of residents. The 10pm to 7am curfew meets all 6 criteria required by national law: it is reasonable, non-arbitrary, and non-discriminatory, it must apply to all airlines. It does not create an undue burden on interstate or foreign commerce as the much larger Dulles International airport and BWI better serve that purpose. It is not inconsistent with maintaining the safe and efficient use of navigable airspace. In fact I asked the FAA to explain how less flights at Reagan would be much safer in such a crowded area. This restriction does not conflict with laws or regulations of the United States, could be open for public comment, and does

not burden the national aviation system, port. It should also help achieve MWAAs stated goal to shift traffic to struggling Dulles. Until the curfew can be reestablished, all flights outside the curfew must depart south over the longer, wider river using two way operations, an established DCA procedure and solution used in other areas including Boston Logan.

Fourth, MWAA must return altitude and when Dulles fails. noise data to their online tracking system, and publish meaningful noise reports at Lab School Construction Upleast guarterly like Cleveland Hopkins, not yearly lacking basic data such as fleet mix. In fact, even their standard 2014 report is still not published. The altitude data was recently removed, after residents reported flights as low as 600 feet over our homes and American Airlines insisted this must be a technical error. Interestingly I've spoken to several other airports that use the Webtrak system, and all have reported Webtrak altitudes to be remarkably accurate. Realizing MWAA has now negotiated with the airlines for millions of dollars to save Dulles, one wonders if this creates a direct conflict of interest to acting in the best interest with the part nearer to The Lab School get cut by DC Public Schools Chancelof noise and safety.

Again, the four achievable goals to improve health and safety are first, planes landing over the river in all weather conditions; second, planes taking off over commercial Rosslyn and the less populous west river bank; third, reestablishing a 10pm to 7am curfew; and fourth, ensuring MWAA publishes accurate, timely, and complete altitude and noise data and enforces basic, common sense noise abatement.

To close, these issues are not new, but the yoke seems to be aiming in the wrong direction. In 1950, Congress wanted Dulles built fearing an inevitable disaster at DCA. Now in addition to accidental tragedies, we must fear the intentional act, and it seems clear it is still inevitable whether tomorrow, next year, or in five years, something will of the new high school. DCPS's chief of communications, responding June 5 to my inquiry about the status of Wilson's budget, acknowledged the City Council action. "However, the amount of the additional funding the school will receive has not been determined. We are committed to ensuring that additional funding goes toward supporting the continued success of students and staff at Wilson, as evidenced by the recent appointment of Kimberly Martin as principal." So Martin, who spent the past three years as principal of the 550-student Aspen High School in Colorado, might or might not come to the job with more money to work with than the \$15.6 million allotted for 2015-16 by DCPS. The budget figure is down \$309,600 from the current year, with DCPS's own enrollment projections showing an increase of 170 students to a total of 1,878.

DCPS does not necessarily follow the direction of City Council. City Council's Fair Student Funding & School-Based Budgeting Amendment Act of 2013 called for a special allocation for at-risk students (eligible for food stamps, homeless, in foster care or who are overage for their grade) to be distributed proportionally to schools based enrollment of qualifying students. DSPC distributed the funds at its own discretion. Wilson's \$384,600 allocation for its 343 qualifying students in 2014-15 was short by about half, according to Ward 3 Councilmember Mary Cheh. Henderson, in April 28, 2015 written testimony to City Council about the school system budget, noted that the Wilson community "felt that their allocation was unfair." For 2015-16, DCPS stated that the money has been allocated proportionally.

Henderson stated in her testimony that "we are proud of Wilson's success" and will "monitor Wilson's enrollment and class sizes over the summer to determine if we need to increase funding." The DCPS communications chief said Wilson's 2015-16 budget "will have no impact on out-of-boundary students or the enforcement of rules regarding attendance by such students." While Wilson has an attendance boundary focused on Northwest, students from across the city are enrolled based on a variety of arrangements. Martin will take over June 29, 2015 from interim principal Greg Bargeman, who stood in following the mid-year resignation after six years of Pete Cahall, who departed in conflict with Henderson's office. Cahall has since been named to head Thomas Edison High School of Technology in Montgomery County.

In announcing Martin's appointment as principal, Henderson said in a June 2 message to the Wilson community that the school system each year conducts a national search for principals. Henderson said Martin was the candidate recommended by the Wilson community, whose input was balanced with her own office's review. The Beacon, Wilson's student newspaper, reported in its June 5 edition that the decision by Henderson and a Wilson committee to choose Martin was unanimous. The newspaper said the Wilson selection committee – comprised of parents, students and Dan Shea, who is an instructional superintendent for multiple high schools -- met with three candidates.

Martin spent five years in Lorain, Ohio teaching high school English and history, according to Henderson's message. She was named Lorain Admiral King High School principal in 2003. After two years, she moved to lead Thomas W. Harvey High School in Painesville, Ohio, for seven years. She then went to the post at Aspen High School. The Aspen Times reported that she was named to the job six months after the "abrupt resignation" of the principal who had been in place for two years, and that she was the third principal since 2010.

According to Times articles, her tenure included a no-confidence vote by staff members, the circumstances of which were unclear, followed by "outpouring of support" from parents and students, as well as efforts to mediate police-school community relations after a forceful arrest at a bus stop near the school of a student suspected of marijuana possession underage. Martin announced her departure in a May 12, 2015 letter to parents. She noted her pursuit of a doctorate in urban education and policy studies and that she had "decided to return to my roots, as it were, and begin working in my area of greatest passion." She expressed excitement about "pursuing a position in a metropolitan area" and having the chance to "get back to work on my dissertation."

According to Henderson's announcement, Martin has a bachelor's degree in English and history from Case Western Reserve University and a master's degree in education from John Carroll University. Henderson's introductory e-mail referred to her as Dr. Martin and stated that she possessed a doctorate from Cleveland State University. A subsequent e-mail referred to her as Ms. Martin and noted that she is "in the process of completing her doctorate." The Beacon reported that Martin's "decision to move to DC began on May 6 when she was offered a position as a DCPS principal and was later selected for the Wilson slot." The newspaper interviewed Martin, quoting her as saying that Henderson is the "most important educator in our country right now" and that Wilson is "fantastic."
