November Membership Meeting

A visit by the Director of the District's Department of Public Works (DPW), Christopher Shorter, will highlight the November 14th FCCA membership meeting (7 PM Hardy Rec Center, 45th and Q). DPW is in charge of most municipal services including trash and leaf pickup, parking enforcement, animal control, snow removal, Fort Totten recycling, and alley cleaning. This is your opportunity to make your voice known on concerns related to these issues! If you have specific questions you would like researched in advance please email Bob Avery (ravery@starpower.net) and he will send them on to the department.

We will also have brief updates from organization representatives on the Georgetown Medstar hospital and DC Water construction projects which have impacted our neighborhood in the past several months.

Finally, the November meeting is also the annual election meeting for the FCCA Board of Directors. Directors serve a one year term, must be a dues-paying member of the FCCA and live within the FCCA geographic area.

Georgetown University & Hostpital Construction Update

Working with DDOT, Medstar Georgetown University Hospital (MGUH) has improved the traffic flow along Reservoir Road. As you may have noticed, No Parking is allowed between 7 a.m. and noon on the south side of the street from the bus stop by the Dental School to Entrance #2. This lane is now only used for vehicles making a right-hand turn into the Hospital Entrance. In addition, Traffic Control Officers are stationed at Entrance #2 and at the traffic light by 39th Street. The FCCA is appreciative of MGHU's response to our concerns about traffic congestion.

In the coming months, pedestrian access to the main campus will be impacted by construction work to prep for a new road connecting the Leavey Center and West Road to Reservoir Road/Entrance 4. Alternative routes for pedestrians and vehicles are being finalized and maps will be issued shortly.

Representatives from the Hospital and the University have been invited to attend the FCCA's meeting on November 14. If they can't attend they'll be invited to attend January's meeting and Board members will take a few minutes to answer questions you have on the 14th.

Membership meeting con't

The Board meets once a month (in the evening, generally the 3rd or 4th Tuesday) and each Director generally assumes responsibility for an area of interest--such as police liaison, school liaison, traffic concerns, FCCA Foxhall News, development-but some members serve "at large." Members are not required to attend all Board meetings but it is hoped that they attend as many as possible. The Board as a whole sets the agenda for the membership meetings and acts in lieu of the membership when issues arise that require immediate action. The Board also elects the Association officers (president, vice president, secretary and treasurer). Because of this it is important that the Board membership be as representative of the entire FCCA community as possible. At this point in time at least one members of the current board is stepping down and one new person has agreed to stand for election. We would welcome more newcomers! 
Update on Call Box Restoration

Thanks to all who came to the FCCA General Meeting at the end of September for the presentation on efforts to renovate and repurpose the six police and fire call boxes in the FCCA neighborhood. We have made further progress since then, meeting with another possible contractor to discuss scope of work and timelines. Once we have a bid from this contractor we will choose a firm we believe can undertake, at a reasonable price, the work of painting the call boxes and preparing the history and art plaques that will be affixed to them. We will then undertake a fund raising effort, with the goal of raising enough funds to start the rehabilitation process next spring. We already have several pledges from those interested in sponsoring this effort.
