Call Box Restoration Project Update


Call Box Committee: Sara Paulson, Bob Siciliano, Hulit Taylor and Ann Haas

You will soon notice that the first phase of restoring our historic Police and Fire Call Boxes is underway! This is Phase I. The contractor, Vision Sign, will strip the old paint on the six call boxes in the FCCA area, repair cracks, replace missing pieces, and paint the fire boxes red and the police boxes blue. Gold paint will be used as a highlight. You can't miss seeing them!

Phase II will begin either later this year or early next year when bronze history plaques telling some of the history of our neighborhood will be installed on one side of each box. On the other side will be art work complementing the history. These can be photos, paintings or bas reliefs. But we need to raise more money before we undertake Phase II!

So far, we have donations and pledges for almost \$12,000 which is enough to complete Phase I. Our goal is \$20,000 which will complete Phase II and have funds for maintenance in the years to come.

FAA Delays Flight Path to Reduce Airplane Noise, Ways You Can Help

The FAA delayed moving the proposed flight path over the Potomac River to reduce airplane noise in response to complaints from Bethesda and Potomac neighborhoods. These neighborhoods are concerned that the new flight path would concentrate more flights over their houses, where today flights disperse before they reach these houses.

In light of the delay, FCCA has asked Mayor Bowser to help reduce airplane noise by requesting to FAA in the next new route negotiation that airplanes increase altitude until they reach 10,000 feet rather than leveling off earlier.

In the meantime, ways you can help reduce airplane noise include:

1) Please continue to complain about noisy flights, especially during 10:00 PM – 7:00 AM via MWAA Noise Complaint Form: https://viewpoint.bksv.com/dca3. You can also register complaints via https://airnoise.io/ - 30 free complaints/month or \$26 for button + \$5/month which gives you weekly reports of your complaints including flight information, time and altitude (these go in the MWAA database but are listed as "unverified").

2) Get a "white noise" machine, available on Amazon.com or Walmart.com. At the recommendation of a neighbor who is no longer bothered by airplane noise, I bought one (Big Red Rooster @ \$19.99), which has worked fairly well for the past few weeks.

The Lab School Opens it New Theater

While a new academic year generally creates a buzz in the school's halls, there is special excitement this fall at The Lab School. In early October, Lab opened its first fullsize theater — The Shaun Miskell Theater — named for Lab's longtime Head of Performing Arts. "This is The Lab School! Arts are part of our core mission," says Shaun. "We have stretched creativity to incredible lengths in [our former black-box] Kelly Theater, but to have a full-size theater with state-of-the-art sound, lighting, and set design to fully realize the educational opportunities that the dramatic arts provide will be a game changer!" Students from every division will use the theater, and not just for performance space. At Lab, the theater is a classroom. "A theater is a place for all kinds of minds to discover talents, overcome challenges, and know thyself," says Head of School Katherine Schantz. "The Shaun Miskell Theater will be Lab's centerpiece for learning — designed for all students at Lab, all of whom learn best through experiences." Community members will be invited to tour the theater at Lab's next quarterly community meeting on December 9.

Reminder About Dumping in Glover Archbold Park

Dumping in Glover Archbold Park (which is part of Rock Creek Park) is illegal. This includes yard waste, because it can carry non-native invasive plant roots or seeds, plant disease, or plant pests that can get established in Rock Creek Park and crowd out or kill native plants. To report dumping in Glover Archbold Park, contact the U.S. Park Police, who maintain a police substation in the park near Military Road, at (202) 610-7500.



Stormwater Runoff And You

Stormwater runoff is causing havoc around Washington, D.C., gouging parkland, collapsing roads, causing flash floods and driving pollutants into waterways.

Cecilia Lane, of the city Department of Energy & Environment's Watershed Protection Division, is trying to "slow it down, spread it out and clean it up."

It's a sizeable undertaking. Lane told the Foxhall Community Citizens Association September 18 membership meeting that about 43 percent of the city's 60 square miles are covered with impervious surface and that an inch of rain can generate hundreds of millions of gallons of stormwater runoff.

Lane looks for opportunities to install landscape features that help soak up and filter the runoff, such as bioswales that include retention areas and plantings. One such project, funded with federal grant money, is underway at the Palisades Recreation Center. Lane said that renovation plans for Hardy Park would be reviewed for stormwater management. The city has adopted regulations that require many types of development include plans to contain stormwater, including certain residential projects.

Lane said the residents can sign up for the city's RiverSmart program, which offers free home site stormwater analysis and assistance with improving management with features such as rain barrels. Lane said that the agency owns no property and must rely on collaboration with other agencies, such as the Department of Transportation and the Department of Parks and Recreation.

In other matters, residents noted their concern about the timing of the traffic light on Canal Road at the Georgetown University entrance. They said that Canal Road traffic is stopped and the delay is long, even when there is no vehicle waiting at the entrance. Residents also noted that traffic control signs at Foxhall Road and P and Volta streets have been knocked down.

Officer Anthony McElwee said that 2D Lt. Darren Haskis is taking a new assignment with MPD Internal Affairs.

for construction of the Medical/ Surgical Pavilion.

"During the remainder of 2019 and into 2020, excavation and structure work will be done approximately three stories deep to support the Pavilion and the underground parking garage. Then, through 2021, we will see the exterior of the Pavilion take shape. During the following year, 2022, work will be focused on the inside of the Pavilion to build out the patient care and support service areas as well as landscaping and hardscaping (pedestrian pathways) of approximately six acres of new green space. In early 2023, construction of the new Pavilion will be complete."

The Foxhall Village Garden Club Had a Busy Summer!

Foxhall Village is not a condominium or other type of planned community with mandatory dues and an association that is tasked with keeping up common areas. Still, Foxhall Village homes are individually owned. But the neighborhood includes many areas that are best described as belonging to everyone and no one. The Foxhall Village Garden Club takes care of these areas. This is an effort by neighbors for neighbors.

This growing season, the Foxhall Village Garden Club has been very active. Of note, members of the garden club have coordinated with the National Park Service through its Weed Warrior program to cut down invasive bamboo at the corner of 44th Street and Foxhall Road. Bamboo is a fast growing invasive species which crowds out other native plants and trees. The cleanup has re-claimed park land for the use and enjoyment of all. Special thanks to Conrad DeWitte, Edward Ponzi, Leo Blyth, Amir Hudda, Andrew Reuter, John Bray, and J.P. Szymkowicz for their help with this continuing effort. Cut bamboo remains stacked and ready to remove; the NPS will be providing a dumpster for the neighborhood to load.

Thanks to **Conrad DeWitte** for rototilling all of the medians on Q Street and Greenwich Parkway, and for making multiple trips in his pickup truck to the Ft. Totton Waste Transfer Station to pick up the compost he mixed into the soil in each of the medians.

The Garden Club weeded, rototilled and re-set damaged permeable pavers in the Q Street median between Surrey Lane and the Q Street Oval. Special thanks to **Doug Neumann** for donating and planting the liriope and to **Sara Paulson** for donating and planting the catmint.

The Garden Club has also completed the

weeding and rototilling of the Q Street median between Foxhall Road and Surrey Lane. Special thanks to **Donna Groat** for her help weeding and for **Gene Kilby** and **Christine Sanderson** for the oak leaf hydrangeas that they planted. Regarding all plants in any of the medians: If you are reading this and have a hose (or a bucket, or a watering can) that can reach the plants, please water them!

Special thanks to Foxhall Village Garden Club members **Joanne Cogar** and **Ed Dorsey**, who came out Saturday, September 28 to help prune the bushes in the Q Street Oval between Surrey Lane and 44th Street. **Christine Sanderson** led the pruning workshop and taught everyone how to prune the bushes correctly. There are still many more bushes to prune. We will be organizing another pruning workshop soon. Also, thank you to Ed for mowing the Q Street Oval this past year!

Conrad DeWitte also rototilled the median on Greenwich Parkway between Surrey Lane and 44th Street. Thank you to **Paul DonVito** for ordering compost, to **Janice Smart** for organizing some planting in the middle of the median, and to **Lisa Maco** and the **Fitzgibbons** for watering the median. Finally the Garden Club has just completed weeding and rototilling the Greenwich Parkway median between Foxhall Road and Surrey Lane.
