# Save Hardy Park and the Foxhall **Elementary School Proposal**

It has been three years since a proposal to place a large public elementary school on Hardy Park was put into the District's capital budget. The new school was proposed to deal with pre-pandemic overcrowding at the three local elementary schools--Key, Mann, and Stoddert. But since that time both the District's population and elementary school enrollment in Ward 3 has dropped. Most importantly, more appropriate proposals to deal with any future growth in elementary school student population have since been put into the budget.

# Update on the New MacArthur High School

In late January, DCPS held its last community working group (CWG) meeting for the new public high school currently referred to as MacArthur High School (MHS). I have been one of two representatives on the CWG. MHS will be located at the former Georgetown Day School campus (purchased in 2021 at 4530 MacArthur Boulevard) on MacArthur Boulevard, and will open in August 2023. Currently, renovation is underway to upgrade the building interior.

DCPS made projections that MHS would begin with 250 students, 200 9th graders and 50 10th graders. Some would be from Hardy Middle School (no definite number was provided), and some will be from out-of-boundary neighborhoods through the lottery program. Although lottery submissions had to be made by February 1st, the 'MacArthur High School' con't on Page 3...

## FCCA Board Elections

The Foxhall Community Citizens Association (FCCA) will have a vote for next year's Board of Directors at our next meeting on February 21st. Directors are elected by a majority FCCA membership and serve one year terms. Only FCCA members residing within the FCCA geographic area may be nominated and serve as Directors. The Board is empowered to transact all necessary and urgent business of the FCCA, including, but not limited to, financial expenditures, membership drives and dues collection, presentations before administrative and legal authorities, and the newsletter publication and distribution. The Board also elects a President who serves for a one year term. The Board of Directors is composed of not less than seven or more than nineteen members.

At present Robert Avery, Carter Beach, Vipul Bhagat, Conrad DeWitte, Paul DonVito, Nikki Farison, Ann Haas, Michael O'Connell, Janet Nash, Sara Paulson, Katherine Samolyk, Peter Van Allen, and Tom Wolfe have indicated they will stand for election.

exact enrollment may not be known until this summer.

DCPS, however, is not requiring Hardy MS students to attend MHS for the next two years, instead allowing current 7th and 8th graders to choose Jackson-Reed High School.

The viability of MHS in 2023 may be an issue, as a question was asked whether MHS could open with only 150 students seeking enrollment. DCPS senior employees and the newly chosen principal Dr. Harold McCray would not provide an answer in the CWG meeting.

MHS's specific academic courses and sports to be offered will be decided in the summer. Only one AP course will be offered, AP History, and both Spanish and Italian likely will be available. The sports, possibly soccer and basketball, will be at the junior varsity level. (Unfortunately, the soccer field is not regulation size for inter-school competitions.) The applications from potential new teachers were submitted in late January, but final teacher choices will not be available until the enrollment size is finalized.

One of the reasons enrollment at MHS may be low is the lack of transportation options - only the D6 bus serves MHS, and commuter traffic delays are significant on Foxhall Road and MacArthur Boulevard during rush hour. The general consensus is that long commutes to schools are not the best for students (at any age). I learned in a CWG meeting that out-of-boundary and some in-boundary students eligible for MHS will have about an hour commute each way using the D6 bus or the closest Metro station, which is nearly 3 miles from MHS. Recently, ANC 3D passed a resolution to seek a new public bus from WMATA to service MHS and portions of Ward 3. (The new city bus route would not service Jackson-Reed.) This action and its supporting documentation will be sent to Mayor Bowser and Council Member Matt Frumin for each to make an earmarked 2024 budget request of approximately \$3.5 million per year. This MHS bus line principally will pick up Ward 3 in-boundary students but add little for MHS students commuting from other Wards.

Specifically, the Glover Park community succeeded in putting \$20 million into the budget to expand Stoddert, which would largely deal with any overcrowding there. Expanding Stoddert would mean that a new school built on Hardy Park would ONLY deal with overcrowding at Key and Mann. But Key and Mann are among the smallest schools in Ward 3, and and they are losing enrollment—not growing. Both are operating well below capacity. Together the two schools have a total enrollment of less than 750 students with fewer than 600 in-boundary.

Carving a third school out of Key and Mann would create three elementary schools operating way below an acceptable scale. It simply makes no sense.

Nevertheless, funds for Foxhall School remain in the budget. Indeed, in our current year budget, the District is supposed to expend funds on planning, with construction slated to begin one year from now. As part of the planning process, the District put out Requests for Proposals (RFPs) last fall. Worse, this proposal makes it absolutely clear that the school would be built on the park, not next to the old Hardy school as some have been saying.

The Foxhall community has made its views clear on the Foxhall proposal for

a long time: In the Spring of 2021 we voted 102 to 15 to oppose the project. We recognize that some people in our community do want the school, and as a community we respect their views. However, at this point, it is evident that the vast majority of people in our area do not want a school to be built on Hardy Park.

No one disputes the fact that Ward 3 schools are popular and in demand. No schools offer PK3 and many have excess demand for PK4. However, there is a strong argument that building the Foxhall School in this location will not solve any potential over-crowding problems in a meaningful way. Worse, it will drain money from other proposals that legitimately would help – both in Ward 3 and across the city.

The first step in the Budget process is the Mayor's office. We need to contact Mayor Bowser and urge her to "do the right thing." At https://mayor.dc.gov/ page/2023-budget-engagement-forums you can find a questionnaire that you can use to voice your opinion on the proposed school. Or you can call 202-442-4755. Finally you can e-mail the Mayor at muriel.bowser@dc.gov. If the Mayor does not take the funds for Foxhall Elementary out of her proposed budget, we will have to go to the DC Council (that will receive the Mayor's Budget on March 22nd). In this case, send the same message to Council Chair Phil Mendelson (pmendelson@dccouncil.gov) and Ward 3 Councilmember Matt Frumin (mfrumin@dccouncil. gov) who are the two key players on the Council.

generally been on "quality of life issues" where our community comes out strongly on one side. Here we fight tenaciously and have generally won.

Our victories include the establishment of the Foxhall and Colony Hill historic preservation districts; the renovation of Hardy Park; the defeat of Georgetown University's "loop road" proposal along Glover Archbold park; and the Landmark Status for the Old Hardy School. The past 15 years have seen major improvements in the "town/ gown" relationship between the community and the Lab School, GDS, and St. Patrick's. This has happened to a large extent because FCCA representatives have attended every school BZA meeting during this period to push for neighborhood interests.

Our current concern is the Foxhall Elementary school proposal which could result in the loss of much of our park (see related article). If this appeals to you, please renew or join our association.
