# Time to Renew FCCA Membership or Consider Joining

The FCCA has long featured an inclusive, transparent governance style. All major decisions are done by vote. Everyone in our area is noticed by hand-delivered newsletters of upcoming meetings. Meetings are open to all—whether members or not. We don't endorse political candidates but rather provide a forum for presentation of views on issues relevant to our neighborhood.

It was hard to operate this way over the past three years of Covid. But we are gradually returning to normal. We have resumed our pattern of semi-monthly in-person membership meetings at the Hardy Rec Center with our next meeting on Wednesday February 21st featuring a visit from Mayor Bowser. We have also resumed social events with our annual Spring Fling at Hardy Park in May and Halloween craft event in the Fall.

As part of this, we encourage those of you that have let your membership lapse to renew and for newcomers to consider joining. The box on the back page tells you how to do it.

What do you get for your membership? Perhaps the most important thing is advocacy. Historically, the FCCA has avoided taking positions on divisive issues where our community is split, feeling that here, individuals are free to advocate their own positions. But when we do take a position, it has generally been on "quality of life issues" where our community comes out strongly on one side. Here we fight tenaciously and have generally won.

Our most recent success was the defeat of the Foxhall Elementary school proposal which would have resulted in the loss of much of our beloved Hardy Park.

Other victories include the establishment of the Foxhall and Colony Hill historic preservation districts; the renovation of Hardy Park; the defeat of Georgetown University's "loop road" proposal along Glover Archibold park; and the Landmark Status for the Old Hardy School. The past 15 years have seen major improvements in the "town/gown" relationship between the community and Georgetown University, the Lab School, GDS, and St. Patrick's. This has happened to a large extent, because FCCA representatives have attended every school BZA meeting during this period to push for neighborhood interests.

## A Brief History of Foxhall

**FOXHALL IS NAMED** for the road that passed by the summer home built by Henry Foxhall in what is now Foxhall Village. Foxhall, born in Wales, arrived in America in 1795—a year after Congress had signed the Declaration of Independence. Foxhall owned the cannon factory on Foundry Creek in what is now Glover Archbold Park. Foxall's cannons are credited with helping to defeat the British during the War of 1812.

**FARMS** — Our area was mostly farmland during the 1800s, including the Ready Farm along Q Street near 45th, and some farms remained intact until shortly before WWII. Foxhall Road, MacArthur Boulevard, and the Palisades area included many summer homes of prominent Washingtonians dating to the late 1800s.

**FOXHALL VILLAGE** was built in the late 1920s. After visiting the English town of Tewkesbury, Harry Boss of the construction firm Boss & Phelps returned to Washington determined to replicate the Tudor-style houses he had admired. By 1927, nearly 150 homes had been finished in the little community of high-end and architecturally acclaimed residences in suburban Washington. Today there are over 300 homes in Foxhall Village, which is now a designated Historic District.

MACARTHUR BOULEVARD, originally named Conduit Road, runs over the water lines that link the Potomac intakes to the old reservoir in upper Georgetown—now the site of the Georgetown Public Library at R and Wisconsin. Conduit Road's name was changed after World War II but Reservoir Road—named for the old reservoir and not the present one— kept its name.

#### **ABOUT THE FCCA**

**THE FCCA IS FUNDED** solely through annual dues and donations, which pay for the newsletter and community events. A high level of community participation, demonstrated by membership, also gives the Association weight in effectively representing neighborhood concerns to government and private groups such as developers and local private schools.

A VOLUNTEER ELECTED BOARD meets to discuss issues and organize bimonthly general meetings, open to all community members, at the Hardy Recreation Center. The Association's informative newsletter, delivered by FCCA volunteers, lets all residents know of upcoming meetings and events, and provides excellent background on issues of concern to help ensure that everyone knows all sides of issues that may affect their neighborhood, quality of life, and home value.

TOGETHER with our Advisory Neighborhood Commission (ANC3D) and sister community associations, the FCCA monitors and acts on a range of neighborhood issues. Over the years, the FCCA has prevented construction of a major roadway through Glover Archbold Park and bridge across the Potomac at Three Sisters; we saved Hardy School (now historically designated and on longterm lease to the Lab School) from being converted to a GU university dormitory; we worked with D.C. Parks and Recreation to restore the playing field and control its overuse; we monitored growth of nearby schools and universities; we pushed for appropriate modifications to numerous undesirable development schemes; we restored the historic Call Boxes in our community and we worked with the DC government to create the Colony Hill and Foxhall Village Historic Districts.

THE FCCA TRACKS a wide range of issues that affect the neighborhood—from historic preservation and pets and potholes to private schools and pollution. We remain very active in mitigating the affects of traffic through the area. We bring items of concern to the attention of residents, assess community opinion, and then act on behalf of the community. We are most effective when we are informed and when we act together.
